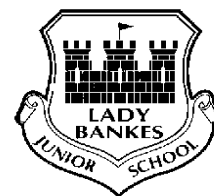

Notes

1. Associate Members are appointed by the Governing Body based on skills and experience. They can vote on committees, if agreed by the governing body, but do not have voting rights at full governing body meetings. Associate Members who are Chairs of Committees do not have casting votes. Associate members are also not permitted to vote on any decision concerning the budget and financial commitments of the Governing Body.
2. Co-opted Governors are appointed by the Governing Body based on skills and experience.
3. Parent Governors are elected by other parents.
4. Staff Governors are elected by staff members of the school.
5. Local Authority Governors are nominated by the LA but appointed by the Governing Body.
